DESCRIPTION

The U.S. Embassy in Islamabad requires services from a social media developer/strategist to develop and manage content (in English and Urdu) for the American Spaces Pakistan Facebook page. The contract will be for a base year, with one one-year optional period of performance in accordance with Statement of Work (SOW).

1.1 TYPE OF CONTRACT

This is a firm fixed price contract payable entirely either in Pakistani Rupees PKR (if contractor is local) and in US Dollars (USD) if the contractor is offshore based. No additional sums will be payable for any escalation in the cost of materials, equipment, or labor, or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required.

1.2 PERIOD OF PERFORMANCE

The contract will be for a period of one-year, with one-year optional period of performance.

2.0 PRICING:

The rates below include all costs associated with providing monthly management in accordance with the attached scope of work.

3.0 **NOTICE TO PROCEED:**

This extra risk analysis vetting is performed on key contractor personnel; including host country, third country, U.S. citizens, and Legal Permanent Residents of the United States. The vetting process applies to all contracts, purchase orders, delivery orders, Blanket Purchase Agreements (BPAs), and BPA calls.

A request for information will be emailed to offerors in the competitive range or selected vendors, and all interested vendors must provide all information requested in the DS Form 4184, Risk Analysis Information. Vendors are required to submit the requested data required for vetting via a secure online portal linking them to the Risk Analysis Management (RAM) office; access to the Portal and instructions for creating an account will be provided to the vendor by email.

Successful passing of vetting is one condition of receiving award. Other factors are price reasonableness and technical acceptability. Each vendor should submit the requested data via the secure online RAM portal within 3-5 days after being contacted. Development and Management of American Spaces Pakistan Facebook Page

Description

Solicitation for a contract by social media developer/strategist to develop and manage content (in English) for the American Spaces (Lincoln Corners Pakistan) [Facebook page](#). American Spaces are called “Lincoln Corners” in Pakistan and are resource centers hosted by universities, cultural centers, and public libraries across the country. Currently there are 18 Lincoln Corners open or in the process of opening, as well as one American Center located at the U.S. Embassy Islamabad. The goal of this contract is to build a robust, responsive, and creative social media presence on Facebook for engaging existing American Spaces Pakistan audiences of emerging voices and youth influencers and attracting new audiences from across Pakistan. (*Refer to [Annex-I](#) for more details on American Spaces Pakistan, and the services they offer*)

The Facebook page is intended to complement and expand the face-to-face activities and programs of the American Spaces Pakistan network by:

1. promoting upcoming events (*refer to [Annex-II](#) for sample events*);
2. developing Facebook campaigns aligned with American Spaces Pakistan’s monthly programming themes to solicit youth opinions and views on the U.S. Mission to Pakistan’s foreign policy priorities (*refer to [Annex-II](#) for a list of monthly themes for calendar year 2022*);
3. optimizing branding, hosting or co-hosting, cross-posting, and advertising opportunities for American Spaces Pakistan’s frequent virtual programs; and
4. advising on strategies to attract and retain followers.

The contract will include advising on branding, content creation and editing (videos, graphics, and text), managing social media community engagement, hosting Facebook Live events, designing high-quality graphics, administering advertising, promoting or cross-promoting events, detailed analytical reporting on post and program performance, audience demographics (gender & age), city-wise analytical data, times for most engagement, comparative performance analysis of static posts vs. Facebook Live programs, etc. Content created for the page must be high-quality and require minimal editing or corrections.

the Lincoln Corners Pakistan Facebook page currently has an audience of 24,000 followers. Our ideal target audience includes emerging voices and young changemakers, and this Facebook page provides us with the opportunities to engage with them, seek their perspectives, and offer them programs that can improve their lives.

Who is the target audience?

Our primary target audience are social media-savvy, undergraduate and graduate students, aged 17 to 26, who are interested in programs and content that helps them build new skills, express themselves, make new connections, and change their opinions about the United States. Some target audiences may have attended American Spaces Pakistan programs before. Additionally, specific middle school, high school and professional audiences may be targeted for programs and content relevant to their academic and career needs, respectively.

Goal

To build a robust, responsive, and creative social media presence on Facebook for engaging existing American Spaces Pakistan audiences of emerging voices and youth influencers and attracting new audiences from across Pakistan.

Objectives

- Promote 2-3 key upcoming virtual events for each of the 19 American Spaces per month
- Develop monthly thematic social media campaigns annually aligned with American Spaces Pakistan's programming themes to solicit youth opinions and views on the U.S. Mission to Pakistan's foreign policy priorities. Content should deliver high-quality, clear and concise English that requires little editing from U.S. Embassy staff. (*refer to Annex-II for a list of programming themes*).
- Optimize branding, co-hosting, cross-posting, and advertising opportunities for American Spaces Pakistan's frequent virtual programs with approximately 3 co-hosted or cross-posted programs per month. The Lincoln Corners Pakistan page frequently cross-posts from the [Lincoln Corners Sindh](#) page, which is managed through a separate cooperative agreement.
- Advise (on a monthly basis) on strategies to attract and retain Facebook followers based on Facebook analytics, with an aim to reach 45,000 followers by the end of the year.
- Set up ads for the Facebook page and boost individual posts for key events.

Where will the program take place?

Online.

How many Embassies/Consulates are involved?

4 posts (Islamabad, Karachi, Lahore, and Peshawar): The scope of work for this contract includes the countrywide American Spaces network (*refer to [Annex-I](#) for a complete list of American Spaces in Pakistan*)

When will the program happen?

One month after contract award.

Will a VPN be required for security?

No, a VPN will not be required, however the contractor will need to use multi-factor authentication when logging into Facebook.

Is there an estimated amount of content we should expect to post on a daily basis?

On average, we expect to upload 3 to 4 posts per day. Posts can be about upcoming events, events that already happened, graphics to create awareness about upcoming internationally recognized observances (like International Education Week), pictures about resources in the Lincoln Corners, video content produced by the contractor, or shared content from other U.S. Mission-affiliated pages. Most content should be in English.

Will content be provided?

Basic information about the Lincoln Corners will be provided by the U.S. Embassy or Consulate (such as event title, pictures, and testimonials). Creative content development will be the responsibility of the contractor and should complement content of other U.S. Mission social media platforms.

What is the period of performance?

One year with an optional period of another year that will be exercised at the will of the U.S. Government.

Can the work take place in the continental United States?

Yes, organizations inside the United States can submit bids for the contract. However, U.S.-based organizations should be willing to work 8:00am-4:30pm (Pakistan-standard time) if they are awarded the contract.

Required Skills:

Digital marketing companies operating in Pakistan with demonstrable expertise in handling Facebook accounts for reputed clients. The ideal applicant organization should have:

- a) A minimum of 5 years of experience in managing social media pages with at least 100,000 followers or if does not have, can show a steady progression in growth of followers.
- b) A detailed portfolio of social media services along with quantitative impact of campaigns curated
- c) A client base consisting of multiple active accounts including five reputable organizations/brands or if does not have, can show a steady increase in number of accounts.
- d) Thorough understanding of the U.S. culture, history and American figures demonstrated through a campaign promoting any international brand, celebrity, or theme
- e) Experience working with foreign missions, U.S. companies, United Nations, or International NGOs
- f) Some of the staff (at least two point of contacts) must have English proficiency at Native or Bilingual level. We may ask for a TOEFL test with a score of 100+ for two team members”
- g) Documentary proof of certifications in Graphic Design Suite, Media Literacy and Digital Marketing
- h) Technically skilled staff, with at least 1 member having an undergraduate degree (at minimum) or exchange program participation from the United States or an English-speaking country. Alternatively, the staff could have lived in the United States for a significant period of time in order to acquire knowledge of American history and culture.
- i) Knowledge of landscape of social media influencers, as demonstrated by how many such influencers the company has previously engaged
- j) Availability of tools for campaign design, execution, and monitoring
- k) Mechanism and tool for organization of design/content creation and approval flow between client and firm.
- l) Experience curating content tailored towards youth of Pakistan resulting in demonstrated engagement

Annex-I

About American Spaces in Pakistan

American Spaces are physical locations that welcome local residents to connect – with people, with ideas and with the United States through collaboration and self-discovery. They serve to build bridges between the people of the United States and Pakistan through various programs and events. The physical spaces impart a welcoming and inspiring American-themed environment and are also equipped with an array of resources, such as books, computers, other modern technology and information about the U.S., just to name a few.

American Spaces also regularly partner with different American or Pakistani organizations/individuals to bring innovative programs to the space. The variety of programs and events held are free and open to the public and enable U.S. & non-U.S. citizens to increase mutual understanding, collaboration and partnership.

The network of 19 American Spaces in Pakistan consists of one American Center at the U.S. Embassy in Islamabad and 18 Lincoln Corners spread across the country.

American Center Islamabad

American Center Islamabad is the main resource in Pakistan for American culture, education, and information. A comfortable, tech-forward space for open dialogue, idea generation and innovation, the American Center organizes a wide variety of activities, including discussions on policy issues, speaker series, workshops, movies, and discussion clubs.

The American Center is a place full of social interaction where you can think and work creatively, build cultural bridges, collaborate and make new acquaintances. Our visitor friendly space is free and open to everyone on an appointment basis.

Lincoln Corners (LC)

Lincoln Corners are partnerships between the Embassy of the United States of America and selected institutions in Pakistan. Located within universities, public libraries, and cultural centers, Lincoln Corners are multi-media resource centers, where visitors can connect, practice their English, and learn about America in many different ways.

Lincoln Corners (LCs) provide access to current and reliable information about America through books, magazines, movies, and more. They offer comfortable spaces for learning and open dialogue. Free wi-fi Internet is available to access U.S. information websites and eLibraryUSA research databases. Cultural programs, speakers, and special events bring added excitement to the spaces.

Currently there are 16 Lincoln Corners open across Pakistan. Each Lincoln Corner is staffed by a Lincoln Corner Coordinator – a bilingual Pakistani professional who is available to assist visitors with specific interests about America.

Lincoln Corner Audiences:

Keeping in mind the widespread LC network across Pakistan, the audiences we cater to have varying levels of English language proficiency. Undergrad students from across the country constitute an estimated 55% of the visitors, followed by graduate & post-graduate students at 20%, high school & college students at 15%, and young professionals at 10%. However, one of the goals of the Lincoln Corners is to promote English language learning, and therefore the majority of social media content should be in English.

Frequency of LC Programs/Events

The number of public engagement activities vary for all LCs. Nationwide in FY 2019, on average 9-10 in-person events were organized on a monthly basis by each LC. Since March 2020, when Pakistan began to feel the effects of COVID-19, the national monthly average dropped to 3-4 virtual events by each LC with a marked increase in program attendance. As of May 2022, we have resumed in-person activities while continuing some virtual events as well. Across the Lincoln Corner network, the Spaces are currently averaging around 100 events per month total, however not all events will go on social media. The contractor will have access to the Lincoln Corner monthly calendar of events to help plan outreach.

The American Center Islamabad's programming average before COVID-19 stood at 2-3 in-person events per month, and now that we have a new American Center Director, we anticipate conducting around 3-5 in person and virtual events per month.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS – NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions.* As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C

652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
