The U.S. Embassy Islamabad requires services for Public Sentiment Analysis and Survey, in a professional manner in accordance with Statement of Work (SOW). The contract type is a firm fixed price for Analysis and Survey services. These rates include all costs associated with providing the requested services including labor, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit (except government furnished supplies/equipment). The contract will be for a one-year period, with one one-year optional period of performance.

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price purchase order is for Public Sentiment Analysis and Survey U.S. Embassy, Islamabad, Pakistan in accordance with Statement of Work.
- B. This contract will be one time activity with two phases.

2. PRICING

2.3 Pricing and Payment shall be made in the local currency (PKR); however, foreign firms may submit proposal in USD and will be paid in U.S. dollars.

3.0 NOTICE TO PROCEED:

After contract award and submission of acceptable insurance certificates and copies of all applicable licenses and permits, the Contracting Officer will issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

4.0 VALUE ADDED TAX:

Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates. U.S. Embassy will provide tax exemption certificate issued by Ministry of Foreign Affairs (MFA) based on proforma invoice submitted by the successful contractor if needed.

4.1 Special Requirements Risk Analysis Management (RAM)

Offers that fall within our competitive range require additional processing for companies wishing to do business with the U.S. Embassy in Islamabad, Pakistan.

This extra risk analysis vetting is performed on key contractor personnel; including host country, third country, U.S. citizens, and Legal Permanent Residents of the United States. The vetting process applies to all contracts, purchase orders, delivery orders, Blanket Purchase Agreements (BPAs), and BPA calls.

A request for information will be emailed to offerors in the competitive range or selected vendors, and all interested vendors must provide all information requested in the DS Form 4184, Risk Analysis Information. Vendors are required to submit the requested data required for vetting via a secure online portal linking them to the Risk Analysis Management (RAM) office; access to the Portal and instructions for creating an account will be provided to the vendor by email.

Successful passing of vetting is one condition of receiving award. Other factors are price reasonableness and technical acceptability. Each vendor should submit the requested data via the secure online RAM portal within 3-5 days after being contacted. Vendors who do not provide the information will not be considered for contract awards.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

DESCRIPTION:

The U.S. Mission in Pakistan—including Embassy Islamabad and the Consulates General Karachi, Lahore, and Peshawar—works closely with the people of Pakistan on issues ranging from education, health, climate, and infrastructure development to food & water security, clean energy, and trade & investment. The objective of our partnerships and of U.S. civilian assistance is to strengthen civil society, enable inclusive economic growth, and support democracy and human rights for a more stable, prosperous Pakistan. The contract will be one time with two phases. The research shall be conducted against the Statement of Work (SOW) provided below.

To advance these goals and the U.S.-Pakistan bilateral relationship, the U.S. Embassy’s Public Diplomacy Section carries out a range of public-facing campaigns and initiatives.

The U.S. Mission believes that understanding public opinion and public sentiments is a critical first step for effective program design. With a view towards producing concrete data built on rigorous research and credible survey analysis, the U.S. Mission seeks a nationwide public opinion research survey to build a comprehensive and objective understanding of:

- How the various demographics within the Pakistani public views the United States, the U.S. government, U.S. government programs, the American people, and the bilateral partnership;
- How Pakistani citizens perceive U.S. government policies;
- What messaging works best to constructively engage Pakistani audiences.

This public sentiment analysis project aims to provide the Public Diplomacy Section with a comprehensive, data-driven audience insight overview. We seek to improve the Mission’s understanding of what our Pakistani target audiences think of the bilateral relationship. We hope to learn how to best tailor messaging when engaging on specific themes.

Beyond the overall goal of improving our approach to public diplomacy, the idea that we are entering a “new era” of U.S.-Pakistan bilateral relations has become an important part of the Mission’s public messaging strategy. We seek to broaden the Pakistani public’s perception of the United States as a partner and confront misperceptions about the United States. As we embark on this reinvigorated effort to highlight the long-standing, diverse partnerships that have always been important aspects of our relationship, we seek to better understand where there might be resistance to that message.

OBJECTIVES

- Effect comprehensive qualitative and quantitative research on how various geographic, economic, and social demographics within the Pakistani public perceive the bilateral

relationship between the United States and Pakistan, as well as current and past U.S. assistance to Pakistan.

- Establish subject areas where the U.S. Mission has a comparative advantage and the most compelling messaging practices for each identified sector.
- Clarify the media consumption habits of Pakistani target audiences—including medium, outlets, and frequency—and who and what influence public opinion.
- Identify challenges and possible solutions related to current U.S. government messages and messaging methods in Pakistan.

SERVICE DESCRIPTION

The U.S. Mission in Pakistan requires the services of a well-reputed public survey contractor, with the capacity to work across Pakistan, to provide the Public Diplomacy Section of the U.S. Mission in Pakistan with a comprehensive, data-driven audience insight overview. The contractor will be required to perform a public sentiment survey and hold focus-group discussions across the country to present comprehensive qualitative and quantitative research on Pakistani public perceptions of the bilateral relationship, how those perceptions vary depending on various factors such as geography and demographics, and how the United States can improve its public messaging and image.

The contractor will also be required to identify the public’s trusted sources for information, offer insights into how and where the U.S. Mission needs to effectively engage specific target audiences, and provide guidance for communication and outreach strategies. The contractor will be required to offer the survey results with demographic and regional distinctions.

The proposals must include a full description of the survey mechanisms and focused group discussions to carry out the comprehensive public sentiments survey both in rural and urban areas across the country with regional and demographic breakdowns related to our target audiences, as defined below.

In drafting proposals, applicants should keep in mind that the goal of conducting the public sentiment survey is to use the information gleaned to improve the U.S. Mission’s public diplomacy and messaging efforts in Pakistan.

TARGET AUDIENCES

- Primary target – standing audiences with which we regularly engage
 - 18-50 age group: educated with a university/college degree; living within urban areas
- Secondary target – audiences with which we rarely engage
 - 18-50 age group: less educated individuals living within urban and rural areas, who often fall prey to false stereotypes and disinformation.

- Tertiary target – audiences with which we rarely engage
 - 18-50 age group: uneducated and marginalized communities living in rural areas

PHASE 1: U.S. MISSION SENTIMENT

- Establish a baseline on public opinion data
- Analyze the data collected from survey and focus-group discussions, provide methods to break it down by demographic and other factors, and identify key areas of concern for the Mission’s work.
- Develop recommendations for messaging on specific topics, themes, audiences, or other messaging possibilities.

PHASE 2: SECTOR SPECIFIC RESEARCH

- Provide analysis and data on additional, specific audiences and topics as identified during Phase 1.
- Develop actionable insights that will assist in future campaign messaging and strategic media deployment.

Both phases should take on the following:

- Develop a research scope that embraces both qualitative and quantitative research methodologies and uses multiple languages spoken in Pakistan.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
3. PROCEDURES.
 - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
 - (b) The COR will complete appropriate documentation to record the complaint.
 - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
 - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
 - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7).
