The U.S. Embassy Islamabad requires Audit Services for U.S. Embassy Projects across Pakistan, in a professional manner in accordance with Statement of Work (SOW). The contract type is Indefinite Delivery Indefinite Quantity (IDIQ) with a firm fixed unit price for audit services. These rates include all costs associated with providing the requested services including labor, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit (except government furnished supplies/equipment). The contract will be for a one-year period, with one one-year optional period of performance.

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this IDIQ contract is to provide Audit Services for U.S. Embassy Projects across Pakistan in accordance with Section-1 Statement of Work.
- B. The contract will be for a one-year period from the date of the contract award, with one-year optional period. For each effective year of the contract, the U.S. Government guarantees a minimum order of 15 audits. The maximum number of audits ordered under each year of the contract will not exceed 20 Audits.

2. PRICING

Pricing and Payment shall be made in the local currency (PKR).

2.4 VALUE ADDED TAX (VAT).

Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices. US Embassy is exempt from local taxes and will obtain tax exemption certificate from Ministry of Foreign Affairs (MFA) on case by case

2.5 Special Requirements Risk Analysis Management (RAM)

Offers that fall within our competitive range require additional processing for companies wishing to do business with the U.S. Embassy in Islamabad, Pakistan.

This extra risk analysis vetting is performed on key contractor personnel; including host country, third country, U.S. citizens, and Legal Permanent Residents of the United States. The vetting process applies to all contracts, purchase orders, delivery orders, Blanket Purchase Agreements (BPAs), and BPA calls.

A request for information will be emailed to offerors in the competitive range or selected vendors, and all interested vendors must provide all information requested in the DS Form 4184, Risk Analysis Information. Vendors are required to submit the requested data required for vetting via a secure online portal linking them to the Risk Analysis Management (RAM) office; access to the Portal and instructions for creating an account will be provided to the vendor by email.

Successful passing of vetting is one condition of receiving award. Other factors are price reasonableness and technical acceptability. Each vendor should submit the requested data via the secure online RAM portal within 3-5 days after being contacted. Vendors who do not provide the information will not be considered for contract awards.

2.6 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

[1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

- (a) Develop and maintain checklists of duties to be carried out,
- (b) Ensure these duties are carried out by the supervisory staff and senior employees, and
- (c) Perform inspections at all work locations to determine whether the various services are being performed according to the contract requirements.

The Contractor shall provide copies of all inspection reports to the COR.

The Contractor shall promptly correct and improve any shortcomings and/or substandard conditions noted in such inspections. The Contractor shall to the attention of the Contracting Officer or COR, for disposition, any conditions beyond the responsibility of the Contractor.

2. STANDARD. The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

3. DESCRIPTION

The Public Affairs Section of the U.S. Embassy in Islamabad needs compliance audit services (referred to as an Audit) by audit firms (referred to as the Contractor) throughout Pakistan to verify expenditures in expense ledgers of its grant awards (referred to as the Project) provided to grantees (referred to as Implementer). The contract will be for a base year period of performance plus an option of one-year. The Audit shall be conducted against the Statement of Work (SOW) provided below.

A) The Goal

The goal is to ensure that funding provided to our implementing partners is expended within the scope of agreed objectives and in accordance with the Award Provisions and U.S. Standard Terms and Condition listed in the award (referred to as Agreement) and to identify/assess any breaches of internal controls in financials and operations. For any identified lack of internal controls, recommend necessary controls relating to finance and operations via corrective action plan (referred to as a CAP) to the implementing partners (referred to as the Implementer)

B) The Objectives

The objective of these audits (referred to as *Audit*) will be to:

- Provide confidential reporting on the findings of the Audit with line-item expenditures to the PAS Management Officer to identify any undisclosed related party transactions and their impact on the award.
- Review the expenditures of the Implementer as intended in the relevant documents, among others.
 - (a) the posted Notice of Funding Opportunity as per grants.gov,
 - (b) the Implementer's award application package, and
 - (c) approved budget; and
 - (d) the agreement between PAS and the Implementer, DS-1909, plus subsequent updates to the agreement, if any.
- Ensure material expenditures are supported documentarily, that they contribute and/or achieve the objective(s) as laid out in the terms of the agreement, and that they follow the written internal controls and policies of their own organizations.
- Evaluate the effectiveness of the Implementer's internal control systems and recommend stronger internal controls to them via CAP, when necessary.
- Identify material misstatements, unusual transactions, unauthorized charges, conflict of interests, nepotism, or any other business irregularities, if any.
- Determine whether the project costs incurred, paid, and charged to the project are allowable, allocable, reasonable, supported by evidence and necessary in accordance with the terms of the Agreement.

- Provide confidential reporting on the findings of the Audit with line-item expenditures to the PAS Management Officer to identify any undisclosed related party transactions and their impact on the award. This confidential reporting may also include references to any limitations in obtaining sufficient or appropriate audit evidence.

C) Is there a timeline and what are the required procedures to begin an audit?

These are suggested timelines from official placement of an Audit order to presentation of Audit findings within a three- month period. It is incumbent upon the Contractor to propose a workable period based on locality, distance, and facilitated contact with involved parties and to build other considerations into the timeline. PAS emphasizes that efficiency is a factor for consideration, however, the importance is on the effectiveness of the Audit and ultimately, its complete reporting of its audit - electronic and/or in-person. The suggested timelines are as follows:

- Within 15 workdays (Mondays to Fridays) of a contract, PAS will initiate and obtain approval for an internal purchase request for Audit service. This timeline is subject to U.S. Government process in the event of situations that are beyond its control including its fiscal year-end process i.e., September 30, after which no financial transactions shall be approved until funds are confirmed available in the new fiscal year.

Upon the receipt of a fixed price order placed by PAS, the Contractor shall:

- Within fifteen workdays, PAS shall electronically send all relevant documents; the official grant funding notice, the Implementer’s application package to include its proposal, organizational profile, program budget, assigned staff, signed grant agreement and any subsequent terms agreed to in writing, if any, and the expenditure report submitted by the implementor on monthly/quarterly/annual basis.
- Within five to seven workdays, after review, the Contractor shall provide an informal written assessment and recommendations on next steps to PAS.
- Within seven workdays, PAS POC and Contractor shall consult with each other, and PAS shall provide written consent to proceed.
- Within five to seven workdays, the Contractor shall have made arrangement to visit the Implementer’s place of business if it is located within the same city. If the business is in another province beyond the Contractor’s location, PAS, Contractor, and Implementer shall agree on a date for an in-person visit.
- Within ten workdays (Mondays to Fridays) after the visit, the Contractor shall provide a brief assessment of the visit to the Implementer’s location.
- Within twenty (20) workdays (Mondays to Fridays), the Contractor shall provide the finding as required in SOW

D) When can the audit begin?

Upon receipt of notice to proceed (NTP).

E) What is the required final audit product?

Throughout the audit, the Contractor shall coordinate with assigned PAS POC. The Contractor shall conduct due audit diligence and produce a final report that is conclusive and includes all aspects of the audit endeavor at the end of the three-month audit period, organized as follows to include the following headings but not limited to:

1. COVER PAGE – includes Contractor and all staff that conducted the audit, date range of the audit.
2. SUMMARY OF FUNDINGS AND RECOMMENDATIONS
3. BACKGROUND to include NGO organizational data, financial decision-makers, programmatic principals, key staff and roles,
4. GRANT COMPLIANCE with the Terms of the Agreement
5. GRANT NON-COMPLIANCE with the Terms of the Agreement
6. ETHICAL CONCERN(S) OR VIOLATION(S), if any
7. CONCLUSION

(a) *Definitions.* As used in this clause—

Foreign person means any person other than a United States person.

United States person, as defined in 26 U.S.C. 7701(a)(30), means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 7701(a)(31)); and
- (5) Any trust if-
 - (i) A court within the United States is able to exercise primary supervision over the administration of the trust; and
 - (ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) This clause applies only to foreign persons. It implements 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c)

(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. to the Tax Court if the IRS determines to sustain the lien filing. In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. §6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. §362 (the Bankruptcy Code).

52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS – NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions.* As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

(1) A citizen or resident of the United States;

(2) A domestic partnership;

(3) A domestic corporation;

(4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and

(5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.
